MI, one son and daughter in-law; William J. and Becky Fay Glocheski of Surprise, Arizona, four grandchildren Douglas (Kristen) Spencer Jr., Robert Spencer, Elizabeth Copeland and Sara Copeland, two great grandchildren Alyssa Spencer and Casey Spencer, two sisters and a brother in-law Eleanor Miller and Clarice and Leonard Wittlief all of Manistee, MI, two brothers and sisters in-law, Bernard and Joyce Glocheski of Otsego, MI, and Patrick and Carol Glocheski of Banning, California. He was also preceded in death by his son in-law Douglas Spencer and by three sisters Dorthea Paprocki, Joan Froncek and Marie Ballard and by one brother James Glocheski.
